- **I. Approval of the minutes** 2018 Annual Meeting minutes were reviewed by the Board and membership present. A motion was made to accept the Annual Meeting minutes as written, a second was provided and all were in favor. The minutes were approved as written.

- V. 2018 Financial Report: Karl Goering from Armstrong, Vaughn and Associates gave the financial report of the association. In 2018 a review was done instead of a compilation, which is a more in-depth look at the financials for the Association. Armstrong, Vaugh and Associates did find that the Associations financials were in accordance with GAAP and free from material modifications. The Board had multiple questions for the auditor and all questions were answered to the Board's satisfaction. Treasurer Judi Cannon gave a financial overview of the Associations financials as of the date of the meeting.
- VI. Homeowner Forum: Homeowner asked if the retaining wall on WCV could be cleaned to match the new retaining wall installed. Homeowner asked about the monument light power and power at the clock tower island. The CM explained that the power is located in the back yard of homeowners and the Board asked to have the contractor relocate the photocell out of the backyards. The Board gave the approval to have them moved.
- VII. Election Results: Kevin Drummonds and Daniel Schafer were both elected to the Board of Directors, both will serve two-year terms.
